ORDER DISMISSING PROCEEDING

On March 8, 2011, the Georgia Division of the Federal Motor Carrier Safety Administration (FMCSA) issued a Notice of Claim (NOC) against Bulldog Movers, Inc. (Respondent) charging it with one violation of 49 CFR 391.11(b)(4)/391.11(a) – Using a physically unqualified driver.² The NOC proposed a civil penalty of \$3,740.

By letter dated April 1, 2011, Respondent replied to the Notice of Claim.³ Respondent admitted the violation and requested binding arbitration.⁴ On May 27, 2011, FMCSA's Field Administrator for the Southern Service Center (Claimant) consented to Respondent's request for binding arbitration. On September 1, 2011, I referred this matter to binding arbitration.



On December 5, 2013, Claimant filed a Motion to Close Docket. Claimant states that he will not be pursuing enforcement action against Respondent for the violation alleged in the NOC.⁵

It is therefore ORDERED, that the Motion to Close Docket is granted, the proceeding is dismissed with prejudice, and the docket is closed.
